GROUP ACCIDENT COVER

Students and Members are covered whilst;

Dancing / Performing Australia wide in organised training sessions, competitions, displays, performances etc.

Traveling to/from their Dance / Performance activity; to/from their residence, school or place of employment.

Touring Worldwide for the purpose of participating in dancing or performing arts whilst representing their studio, club, organisation or National Body.

BENEFITS

Death and Disablement Benefits: Up to \$50,000 (Under 18 years of age \$10,000).

Medical Expenses: Non-Medicare medical expenses reimbursed up to \$2,000 per injury, including:

Ambulance, Chiropractic, Masseur, Private Hospital, Dental Service, Theatre Fees, Naturopath Osteopath Physiotherapy, Orthotics & Prosthesis

Note: *a) non-Medicare Medical Expenses are reimbursed up to a maximum of 80% except physiotherapy which reimburses up to 95% of initial 5 visits, 80% of the next 6-10 visits and 75% of subsequent visits up to the overall limit of \$2,000 per claim.*

b) Members who are not covered by Private Health Insurance are subject to a \$50 excess per claim.

c) Due to Government Legislation, members cannot be covered for any part of any "Medicare" e.g. Doctor, Surgeon, Anaesthetist, X-ray related account.

Student Allowance For full time students (Costs incurred for tutoring, travelling, etc. up to a max. of 200pw)

Domestic Home Help For non income earners (Costs incurred [as per policy] up to a max. of \$200 per week)

Loss of Income For full time employees. (Up to 75% of weekly salary, to a maximum of \$200 per week
Excess: 7 days.)

Conditions

- The maximum claimable period is up to fifty-two (52) weeks per claim.
- All injuries and incidents must be reported to the studio at the time of the injury
- Lodging a claim; Contact AASCF for a claim form, all completed forms should be lodged with AASCF within 30 days of the injury.
